North Africa Congestion & Logistic Imbalance Surcharges  
All Services Outbound Canada**

Dear valued customers,

Effective **November 1<sup>st</sup>, 2009**, CMA CGM (Canada) Inc. will apply **Congestion (CS) and Logistic Imbalance Surcharges (LIS) on all cargo moving from Canada to North Africa** destinations. The new surcharges listed below will apply to all cargo received on or after the effective dates specified below.

**Congestion Surcharge (CIS)**

Effective Date	Destination	Surcharge Level
November 1, 2009	Algiers	USD \$300 / TEU
November 1, 2009	Bejaia	USD\$30 / TEU
November 1, 2009	Tripoli	USD\$160 / TEU

**Logistic Imbalance Surcharge (LIS)**

Effective Date	Destination	Surcharge Level
November 1, 2009	Algeria	USD \$200 / TEU
November 1, 2009	Libya	USD \$200 / TEU
November 1, 2009	Casablanca	USD \$200 / TEU
November 1, 2009	Agadir	USD \$120 / TEU
November 1, 2009	Tangiers	USD \$200 / TEU

December 1, 2009	Algeria	USD \$220 / TEU
December 1, 2009	Libya	USD \$220 / TEU
December 1, 2009	Casablanca	USD \$220 / TEU
December 1, 2009	Agadir	USD \$140 / TEU
December 1, 2009	Tangiers	USD \$220 / TEU

As a reminder, the following previously implemented surcharges will still apply to all shipments from Canada to North Africa destinations.

**Peak Season Surcharge (PSS)**

Effective Date	Destination	Surcharge Level
August 15, 2009 until further notice.	<b>All North Africa destinations</b>	USD \$150 / TEU

**Emergency Freight Revision (EFR)**

Effective Date	Destination	Surcharge Level
August 1, 2009 until further notice.	<b>Morocco destinations only</b>	USD \$300 / TEU

All of the surcharges mentioned above are specific to North Africa trade, and can be modified as the operational situation requires, given 15 days advanced notification.
